

## Cumbria Global Health and Wellbeing Scholarship 2026/27

### Terms and Conditions

These terms and conditions apply to the Cumbria Global Health and Wellbeing Scholarship offered at University of Cumbria only.

#### Summary

- Total value of scholarship - undergraduate: up to £12,000
  - *Annual award of £4,000 payable each year*
- Total value of scholarship - postgraduate: up to £4,000
- Deadline for **all conditions** to be met for relevant deposits to be paid as follows:
  - Nursing (undergraduate): 12<sup>th</sup> August 2026
  - Nursing (postgraduate): 17<sup>th</sup> July 2026
  - Master of Public Health: 5<sup>th</sup> March 2027
- Scholarships will be automatically deducted from the annual tuition fees on registration at the University of Cumbria
- There is no cash alternative for the award.
- This award cannot be held in conjunction with any other university awards or discounts
- The university retains the right to withdraw this scholarship, at any time prior to 19<sup>th</sup> August 2026

#### Eligible Health and Wellbeing programmes

International applicants holding an offer for one of the following full-time programmes delivered on the Carlisle or Lancaster Campuses may be eligible for the Cumbria Global Health and Wellbeing Scholarship:

##### Undergraduate Programmes

- BSc (Hons) Children's Nursing
- BSc (Hons) Learning Disabilities Nursing
- BSc (Hons) Mental Health Nursing
- BSc (Hons) Nursing/Registered Nurse: Adult Nursing

##### Postgraduate

- MSc (Hons) Nursing/Registered Nurse: Adult Nursing
- MSc (Hons) Nursing/Registered Nurse: Mental Health Nursing

##### Postgraduate delivered by distance learning

- MPH Master of Public Health

#### Other Eligibility Criteria

1. To be eligible for the Cumbria Global Health and Wellbeing Scholarship, applicants must hold an offer of a place of study on an **eligible programme** listed above.
2. Only applicants with an offer of a place in 2026/27 will be considered for the award.
3. All applicants must be self-funding students with **overseas fee status**.
4. For postgraduate students: All offer holders must be holding, or on track to be awarded, the equivalent of a minimum of a UK 2:2 bachelor's degree will be considered for an award.
5. For undergraduate students
  - a. Students applying for a bachelor's degree with a placement year may be eligible for the International Undergraduate Scholarship, however, it must be noted that the award is **not payable during the placement year**.
  - b. Only offer holders with, or on track to be awarded, the minimum required academic qualifications will be considered for an award

*Note: Students progressing onto degree programmes at University of Cumbria, from the International College, will be considered eligible for Cumbria Global Health and Wellbeing Scholarship providing all eligibility criteria have been met.*

### **Value of Scholarship**

- **MSc programmes:** £4,000 payable as a fee reduction in first year only
- **BSc programmes:** £4,000 payable as a fee reduction each academic year (up to three years)
- **MPH programmes:** £4,000 payable as a fee reduction in first year only if studying full time. Pro-rata if studying part-time (£2,000 per year)

### **Applying for the Cumbria Global Health and Wellbeing Scholarship**

- There is no need to apply for this scholarship, if the applicant is eligible, the award will be automatically applied to reduce the tuition fee payable.

### **Eligible award holders**

1. Scholarships can only be taken during the 2026/27 academic year and cannot be deferred to any other period.
2. Published tuition fees apply to the stated academic year only and may be subject to inflationary increases in subsequent years of study.
3. Scholarships will not be awarded to applicants in receipt of a scholarship from any other source.
4. This scholarship cannot be combined with any other scholarship or discount and, if a successful applicant is offered more than one University of Cumbria award, only the award of the greater amount will be granted.
5. Should a successful candidate transfer programme, the scholarship may no longer be valid and may be withdrawn.
6. Should a successful candidate withdraw/suspend from a programme of study the student will be liable to pay tuition fees in accordance with the university's tuition fee policy.
7. All successful scholarship holders will be invited to support the university with appropriate internationalisation events and provide a photograph and statement to be included in our publicity.
8. The University of Cumbria retains the right to withdraw the scholarship in the following circumstances:
  - a. It is subsequently found that the candidate is ineligible for the scholarship, for example if the candidate has not met the entry requirements or the terms and conditions of this award.
  - b. Documentation used to apply to a programme at the university are subsequently found to be fraudulent.
  - c. Tuition fees are not paid in accordance with the terms and conditions of this award and/or the university's tuition fee policy.
  - d. The university suspends or withdraws an eligible programme of study for 2026/27 entry
