

Dedicated facilities - you will have access to exclusive 24/7 research facilities at our Lancaster, Ambleside, and Carlisle campuses at times to suit you.





PHD | DOCTOR OF PHILOSOPHY

A PhD at Cumbria allows you to develop your ambitions in a supportive, challenging and innovative research environment.

With supervisory expertise at the intersections between theory and practice, the University offers a range of doctoral programmes to suit your research needs. These include full-time and part-time options for PhDs, PhDs by Art Practice, PhDs by Publication, PhDs by Alternative Format and Professional Doctorates (DProf).

COURSE OVERVIEW:

The University of Cumbria delivers a range of postgraduate research degrees, so you can ensure your programme of work matches your interest and ambitions:

Doctor of Philosophy (PhD): A doctoral-level award assessed through a research thesis and oral defence.


Alternative Format PhD: A doctoral programme where the body of work to be assessed is in a format other than the traditional single volume thesis.

PhD by Art Practice: A doctoral programme where the body of work to be assessed comprises a negotiated set of research outcomes mediated by individual creative and art practice.

PhD by Publication: A doctoral-level award comprising an assessment of a student's published works within a related field of study. To be eligible for consideration, applicants must be a University of Cumbria alumni and graduate of at least five years' standing and have already obtained a master's degree or show evidence of having received research training or equivalent.

UNIVERSITY OF CUMBRIA DOCTOR OF PHILOSOPHY (PHD) STUDENT, DAVE MCPARTLAN TALKS ABOUT HIS EXPERIENCE ON THIS PROGRAMME.

What, or who inspired you to study a PhD?

Having been a teacher for over 35 years I decided to retire and concentrate on training work regarding mental health in schools. I was at a conference and met Prof Kaz Stuart and in the subsequent discussion I mentioned my plans. Kaz gave me details of a funded PhD at the University of Cumbria to complete research related to health strategy. Having just introduced a mental health strategy into my school Kaz suggested I apply. After much soul searching and encouragement from Kaz, I made a successful application and as they say, 'the rest is history'!

What would be your top 3 tips for people thinking of doing a PhD?

- 1) Find something to study that you are passionate about.
- 2) Throw yourself in into the work, immerse yourself in it and enjoy it for what it is, an opportunity for self-development.
- 3) Believe in yourself! PhDs are unique to the individual and if you get the chance to do one, you will be able to shape it in the way you want to.

Please can you briefly describe your thesis/research area?

I went into my research looking to investigate the efficacy of the 'Whole School Mental Health Strategy'. I wanted to do this from the young people's perspective but was concerned that my previous position as Assistant Headteacher would negatively impact the research. The feeling was that the young people may not 'open-up' to me or be honest with me as they would view me as the teacher who used to be in charge of behaviour and attendance. After discussion with different groups of young people from the school we came up with the idea of asking sixth formers to volunteer to work with me as coresearchers and they would collect the primary research data with younger students. This resulted in findings related to the mental health strategy and findings to do with my unique methodology; something I called Youth Participative Dialogic Action Research (YPDAR), a nuanced form of YPAR.

How have your tutors supported you during your studies?

This is almost impossible to quantify! For various reasons I had six different supervisors as a number of them moved on to other roles during my four years. Two of them stayed with me throughout the journey and were an inspiration to me. They took me from being a research novice to completing my PhD with minor corrections. They taught me how to be an academic, how to study and how to succeed, challenging and prompting me whilst also suggesting avenues to explore. They also gave me massive support, particularly in the final write up stages, when I started doubting myself! I really cannot talk highly enough about them!

What have you done since graduating and how did your PhD prepare you for this?

As an older graduate I am now less interested in an academic career path. Instead, I am working as an independent researcher trying to develop my research further. I have taken my methodology and have applied it in another school as well as pitching to other formal youth organisations. As a result of my PhD, I have also been asked to contribute to wider research projects as well as to papers and book chapters. It really has opened up a very different 'work stream' from that which I was used to.

COURSE OVERVIEW:



You will be working with a core interdisciplinary programme team and drawing upon the established expertise of University of Cumbria's academics and researchers.

For students with further study ambitions, it is possible to gain Accreditation from Prior Learning (APL) from the MRes degree into either a Doctor of Philosophy (PhD) or a Doctor of Professional Practice (DProf). To progress from the Master of Research to the PhD or DProf, you will require 60% average overall, Merit or above, on successful completion of the MRes.


- Contribute new knowledge and understanding of key disciplinary and interdisciplinary theory, and research relevant to your professional field, workplace context and chosen focus.

UNIVERSITY OF CUMBRIA MASTER OF RESEARCH (MRES) STUDENT, GEORGIA YOUNG TALKS ABOUT HER EXPERIENCE ON THIS PROGRAMME.

Who or what was your inspiration to study a Master of Research (MRes)?

Tom Grimwood (University of Cumbria, Head of Graduate School) himself! I listened to Tom speak at a conference I had attended, whilst I was in the throes of deciding what my educational "next step" would be. I can't really explain why, but I felt a draw to the programme Tom was presenting and felt the MRes aligned to what I was trying to get out of my educational journey. I emailed off for more information the next week.

What is your research area?

I wanted to focus on paramedic education and development but didn't really know where to start. The programme has stepped us through from foundations of research itself, to narrowing down topics and considering philosophical perspective, which has led me to my final project where I will be looking, ironically, at the paramedic journey into research and all the factors (both hindering and helping) along the way. Ideally, this will be able to provide our education system with some foundations of what aspiring/current research paramedics need to make that jump into a key part of their professional development. Every paramedic has a "thing", and this is my attempt at finding the core of how to best support that paramedic to move their own interests forward to improve practice and patient outcomes.

What would be your top 3 tips for people thinking of doing an MRes?

The MRes will be setting up my academic career to support me to take my research where I want to, and more confidently.

Nearing the end of the programme, my top 3 tips would be:

- 1) You get out of the programme what you put in. Commitment will ensure success.
- 2) Ask the question, don't assume everyone else in the room knows what is going on!
- 3) Don't be afraid of your weak points. In this programme, knowing what these are gives you space to consciously develop your weaknesses and come out with greater depth of knowledge under your belt and a significant critical self-awareness. It is a safe place to practice and to get it wrong.

UNIVERSITY OF CUMBRIA DOCTOR OF BUSINESS ADMINISTRATION (DBA) STUDENT, ROSAMUND CAREY TALKS ABOUT HER EXPERIENCE ON THIS PROGRAMME.

What, or who inspired you to study for a DBA?

Actually, I was sitting in a meeting with top executives from a world renowned conglomerate. Listening to the depth of knowledge and acumen, the manner in which they were able to pivot seamlessly into different subject areas was interesting. I determined then that I wanted that same level of proficiency, knowledge and impactfulness.

Can you briefly describe your thesis/research area?

Healthcare insurance systems are a critical component for citizens to obtain access to affordable, and equitable healthcare. "Strategies in Healthcare Resilience: Exploring a Sustainable Healthcare Insurance System in The Commonwealth of The Bahamas."

What made you choose the University of Cumbria for your DBA?

I perused other DBA programmes. However, with the University of Cumbria, there were several factors in the decision process. The most compelling factors were the composition of the modules, the conducive learning environment, and the keen interest that the professors take in ensuring our success through challenging modules.

What have you enjoyed most at Cumbria?

The diversity of our cohort, the face-to-face interaction at the beginning of each module, and the authentic engagement with our professors.

How have your tutors supported you during your studies?

It is the unwavering support of Dr. David Murphy and Dr. Stephen Taylor. The gentle reminders when they feel a significant time has lapsed between communications. The willingness to engage and offer guidance during difficulties, whether it is academically or personally. This has helped tremendously in the success of the inaugural cohort getting through the proposal stage into the actual DBA thesis. Although we all have our own personal tutors for our specific area of expertise, the guidance and support are still there.

What are your career plans, and how is your DBA preparing you for your future career?

To become a skilled and effective agent of change within the healthcare insurance industry. The DBA programme has enabled me to develop and strengthen a wide range of new competencies. It has provided me with deeper insights into applying learned abilities in practical situations and using various theoretical and conceptual frameworks to make better strategic decisions.


